I can see no conceivable legal justification for action in anything that was said so I can only assume that I will be the actual target of any action. If I am wrong about that I feel an ethical obligation to support anyone else who is.
This is fair warning, there is no way I could afford legal representation, I have none of the usual family or social supports, but, on the other hand there is no way I could retraction or silence. I have told the truth all along, and been treated like a criminal and deliberately placed in danger for lengthy periods of time because of that. At no time has anyone even attempted to interview me in connection with my claims let alone investigate them.
I find it very hard to live with connection with Ruhama, Turn Off the Red Light and the 2017 Sexual Offences act as it is. My physical and mental health has been completely broken trying to stand up for the simple truth over the past 6 years. I have no relationship to SWAI Ireland as I am uncomfortable with the degree of involvement with Escort Ireland.
I have had 72 hours to think about this. Faced with any future judicial demand that I retract the deposition I have sworn I can see no realistic or tolerable alternative but end my life, leaving behind a further death bed statement of other deceit that I am aware of in connection with the 2017 Sexual Offences act. It is the least I can do for the many, many sex workers I have known since, as well as for my own moral conscience.
As to my sanity I was speaking with a Consultant Psychiatrist last week in connection with an unrelated matter. I have lived in fear for 6 years for simply telung the truth and I am exhausted.
I am happy to make a full psychologist's report, and a separate diagnosis available to the Department of Justice and/or Amnesty International. They will confirm that I am autistic which makes it almost impossible for me to sustain any kind of deceit. (I do not trust Ruhama with confidential information under any circumstances.)
